A. East Side Drainage Blockage at Howard Street

B. Prop 218 RFQ Update

City Engineer Brian Ontiveros gave an update on the status of the process. The city planners are preparing the report for the city council who will then vote whether to authorize the funding for the engineering report required to complete the process. The committee discussed the timeline.

C. Francis St Drainage Update

The committee discussed the cost of various solutions to the issue. The property owner has installed 6" drainage pipes on their property to mitigate the water flooding. Discussion was had as to legality of various mitigation efforts.
