If you are doing business in the City of Ferndale, you may need some or all of the following. Please contact Ferndale City Hall for applications and to pay fees.

	Ferndale Business License
	A building Inspection will be required before a new business license is issued or a
	change in business occurs. Please call Arnie Kemp at (707)599-6226.
	The premises will need a fire inspection from the fire department before a new
	business license is issued or a change in business occurs. Please call Ferndale
	Fire Department at (707)786-9909
	Any place preparing or serving food will require a health inspection permit.
	Contact County of Humboldt DEHS (707)445-6215. A business license will not be
	issued until a health inspection is completed.
	Any change to the look of the outside of the building in the Design Review zone,
	including signs, doors, window, paint, will require a "Use Permit – Design
	Review". There are some restrictions on materials, size, color, and lighting. This
	application will go through the Design Review Committee, under the Planning
	Commission.
	All signs must comply with the Sign Ordinance (Ordinance 2013-02) Neon
	Open/Closed signs are strictly prohibited.
	For a Bed & Breakfast, a hotel, or motel, you will need to pay bed tax to the City
	of Ferndale.
	For a home business in a residential zone, you will need a "Use Permit – Home
	Occupancy." This will require a deposit, and the application may go through the
	Planning Commission or be approved administratively.
	In some zones, you may need a "Use Permit" for a particular type of business.
