## New/Change Business Check List –

If you are doing business in the City of Ferndale, you may need some or all of the following. Please contact Ferndale City Hall for applications and to pay fees.

\_\_\_\_\_ Ferndale Business License

\_\_\_\_\_ A building inspection will be required before a new business license is issued or a change in business occurs. Please call Arnie Kemp at (707)599-6226.

\_\_\_\_\_ The premises will need a fire inspection from the fire department before a new business license is issued or a change in business occurs. Please call Ferndale Fire Department at (707)786-9909

\_\_\_\_\_ Any place preparing or serving food will require a health inspection permit. Contact County of Humboldt DEH (707)445-6215. A business license will not be issued until a health inspection is completed.

\_\_\_\_\_ Any change to the look of the outside of the building in the Design Review zone, including signs, doors, window, paint, will require a “Use Permit – Design Review”. There are some restrictions on materials, size, color, and lighting. This application will go through the Planning Commission.

\_\_\_\_\_ All signs must comply with the Sign Ordinance (Ordinance 2013-02) Neon Open/Closed signs are strictly prohibited.

\_\_\_\_\_ For a Bed & Breakfast, a hotel, or motel, you will need to pay bed tax to the City of Ferndale.

\_\_\_\_\_ For a home business in a residential zone, you will need a “Use Permit – Home Occupancy.” This will require a deposit, and the application may go through the Planning Commission or be approved administratively.

\_\_\_\_\_ In some zones, you may need a “Use Permit” for a particular type of business.
