	business license is issued or a change in business occurs. Please call Ferndale
	Fire Department at (707)786-9909
	Any place preparing or serving food will require a health inspection fee. Contact
	Vanessa Huerta to set up an inspection: (707)599-3455. A business license will
	not be issued until a health inspection is completed.
	Any change to the look of the outside of the building in the Design Review zone,
	including signs, doors, window, paint, will require a "Use Permit – Design
	Review". There are some restrictions on materials, size, color, and lighting. This
	application will go through the Design Review Committee, under the Planning
	Commission.
	All signs must comply with the Sign Ordinance (Ordinance 2013-02) Neon
	Open/Closed signs are strictly prohibited.
	For a Bed & Breakfast, a hotel, or motel, you will need to pay bed tax to the City
