Resolution 2025-02 Accepting an Easement for Recreational Trail Purposes: City Manager Jay Parrish explained that this has been a discussion for many years and will be a great asset for the city and Russ Park. City Attorney Ryan Plotz explained that the easement is to be used to establish a trail or trails into Russ Park and construct a parking area with the possibility of a restroom facility. Plotz explained the easement details and the terms of the acceptance of the easement. Councilman Jorgensen questioned if there would be anything that could prevent this from taking place. Plotz stated that it will have to go through a design and regulatory process, however, with the 5-year time allotment given that there should be plenty of time to complete the processes. Councilwoman Fisk-Becker questioned if the construction of the trail is in the budget. Parrish stated that it is not yet, however, it can be discussed for next year's budget, and there may be grants available. Plotz added that only the trail needs to be completed in 5 years, not any parking area or other facilities. Ms. Lorenzen spoke regarding the parking area and encouraged the Council to put in parking as soon as possible as not to create a problem in people driving up and not having anywhere to park.
